The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

# ARTICLEÏ. NAME

The name of the corporation is Tradewinds Clothing & Gifts, Inc.

#### ARTICLE II. DURATION

The term of existence of the corporation is perpetual.
