ARTICLES OF INCORPORATION OF ALPHA OMEGA TRACK & FIELD CLUB, INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE 1 NAME: The name of the corporation shall be ALPHA OMEGA TRACK & FIELD CLUB, INC.

ARTICLE 2 <u>DURATION:</u> The corporation shall have perpetual existence.

ARTICLE 3 <u>PURPOSE:</u> The purpose of the corporation is to engage in any activities of business permitted under the laws of the United States and of Florida.

ARTICLE 4 <u>CAPITAL STOCK:</u> The corporation is authorized to issue 1,000 shares of common stock, at a par value of ONE (\$1.00) DOLLAR per share.

ARTICLE 5 <u>INITIAL REGISTERED OFFICE AND AGENT:</u> The name and address of the initial registered agent and office of the corporation is Susan J. Vien whose address is 7325 Fireside Dr., Port Richey, FL 34668. This is also the mailing address.

ARTICLE 6 INITIAL BOARD OF DIRECTORS: The corporation shall have ONE (1) director initially. The number of directors may be increased or decreased from time to time by amendment of the bylaws in the manner provided by law, but shall never be less than ONE (1). The name and address of the person who is to serve as the initial director is Susan J. Vien whose address is 7325 Fireside Dr., Port Richey, FL 34668.

ARTICLE 7 INCORPORATOR: The name and address of the incorporator is Susan J. Vien whose address is 7325 Fireside Dr., Port Richey, FL 34668.

ARTICLE 8 BYLAW AMENDMENT: The power to adopt, alter, amend, or repeal the bylaws of this corporation shall be vested in the Board of Directors.

ARTICLE 9 <u>INDEMNIFICATION:</u> The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE 10 INFORMAL ACTION OF DIRECTORS: If all of the directors severally or collectively consent in writing to any action take or to be taken by the corporation, and the writing evidencing their consent is filed with the secretary of the corporation, the action shall be valid as though it had been authorized at a meeting of the board of directors.

ARTICLE 11 <u>AMENDMENT OF ARTICLES</u>: This corporation reserves the right to adopt, alter, amend, or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, in accordance with Florida law.
