The undersigned incorporators to these Articles of Incorporation, natural persons competent to contract, hereby present these articles of incorporation for the formation of a corporation under the applicable laws of the State of Florida.

**ARTICLE I. NAME**

The name of this corporation is Independent Air Distributors, Inc.

**ARTICLE II. CORPORATE DURATION**

The duration of the corporation is perpetual.

**ARTICLE III. PURPOSE**

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida

**ARTICLE IV. PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation is 720 Blountstown Highway, Tallahassee, Florida 32304.

**ARTICLE V. CAPITAL STOCK**

The number of shares of stock that this corporation is authorized to have outstanding at any one time is One Hundred (100) shares. Such shares shall be of a single class of stock, and all issued stock shall be held of record by not more than 35 persons. Stock shall be issued and transferred only to (i) natural persons, (ii) estates, or (iii) a trust defined in 26 U.S.C.A. Section 1361(c)(2) (or its successor section). In addition, no stock shall be issued to a non-resident alien. All shares of stock shall have

a par value of Five Dollars (\$5.00) per share.

#### ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The name of the initial registered agent of this corporation is Lannis Lawrence Godwin, Jr. The address of the initial registered office and registered agent of this corporation is 720 Blountstown Highway, Tallahassee, Florida 32304.

#### ARTICLE VII. INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time by the bylaws, but shall never be less than one. The names and address of the initial director of the corporation is:

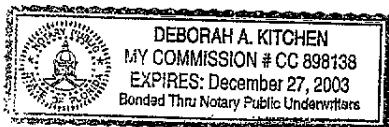
