ARTICLE I: NAME

The name of this corporation is Linda S. Thompson, P.A.

ARTICLE II: DURATION

This Corporation shall exist perpetually.

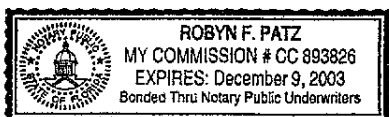
