ARTICLES OF INCORPORATION OF

Adam's House of Ribs, Inc.



THE UNDERSIGNED, acting as sole incorporator of Adam's House of Ribs, Inc. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation shall be Adam's House of Ribs, Inc.

ARTICLE II

<u>Shares</u>

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.

ARTICLE III

Principal Office

The address of the Principal Office of the corporation is 205 N. Highway 27, Minneola, Florida 34711. The location of the Principal Office shall be subject to change as may be provided in bylaws duly adopted by the corporation.

ARTICLE IV

Initial Registered Office and Agent

Initial Board of Directors

The number of Directors constituting the initial Board of Directors of the corporation is three (3). The number of Directors may be increased or decreased from time to time, but in no event shall the number of Directors be less than one (1). The person who is to serve as initial Director until the first annual meeting of the shareholders of the corporation or until such successor Directors are elected and shall qualify are Adam Lee Wilburn, Ruby Jean Wilburn and Davina Smith.
