
Dear Sir or Madam:

Enclosed please find our check in the amount of \$300.00 to cover the 2004 and 2003 Uniform Business Reports for DeRosa & Company Inc. Our CPA has just recently notified me that the 2004 UBR Report is due on May 1. When I went to www.sunbiz.org as the accountant instructed, I was unable to file our report. Upon investigation, our accountant determined that we had neglected to file our first annual report which was due May of 2003. Upon further investigation, she determined that the address on file with your department was an old address, which has not been in effect since mid 2002, and the post office did not forward your notification.

We are a new business, which was incorporated in 2002. I have never been a business owner before such time so I was unaware of this obligation. We have changed the mailing address to our accountant's office so that they can monitor this deadline for us so that does not happen again.
