The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is SUSHI SIAM OF AVENTURA, INC. The mailing address of the corporation is 7510 Beach View Drive, North Bay Village, Florida 33141.
