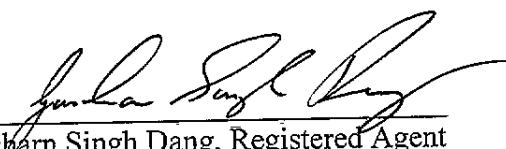
ARTICLE X

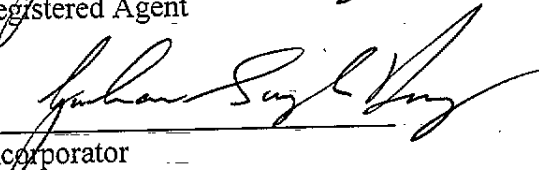
