Pursuant to the provisions of section 607.0124, Florida Statutes, this Florida profit corporation adopts the following articles of correction to its articles of incorporation:

FIRST: The date of filing of the Articles of Incorporation was January 9, 2002 and the assigned document number is P02000002782.

SECOND: The following corrections to the Articles of Incorporation was adopted by the Florida profit corporation:

WHEREAS, the name of the company as stated in the Articles of Incorporation filed with the Department of State was misspelled and should read "Milana, Corp." instead of "Nilana, Corp."


RESOLVED, that Article I of the Articles of Incorporation be, and the same hereby is, deleted in its entirety and the following be, and hereby is adopted in substitution therefore:

"1. Name. The name of the Corporation shall be and hereby is Milana, Corp."

THIRD: The amendment was approved by the shareholders. The number of votes cast for the amendment was sufficient for approval.
