- 1. Name. The name of the corporation is: NSC-OM, INC.
- 2. <u>Purpose</u>. The corporation may engage in any legal business.
- 3. Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1000 shares of common capital stock with no par value.
