ARTICLE I. CORPORATE NAME.

The name of this corporation is: Atelier Designs, Inc., a Florida corporation. Corporate Address: C/O Cesar R. Camacho, 240 East Flagler Street, Miami, Florida 33131.

ARTICLE II. NATURE OF BUSINESS.

This corporation may engage in any activity or business permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE III. DURATION.

any dividends that may be declared by the Board of Directors out of assets

legally available for such purpose.

H. Liquidation Rights: Holders of Common Stock are entitled, in the event of Ilquidation or

dissolution of this corporation, to receive their pro-rata share of any assets of

of this corporation remaining after payment of all corporate

debts and obligations.
