I, the undersigned incorporator of this corporation under Florida Statutes 607, as affected A adopt the following Articles of Incorporation.

# ARTICLE I Name and Address of Corporation

The name of this corporation shall be Casades U.S.A., Inc.

The principal place of business and address is: 2680 SW 100th Court, Miami, FL 33165.

## ARTICLE II Duration

The duration of the corporation shall be perpetual. The date and time of the commencement of the corporate existence of the corporation shall be upon filing these Articles of Incorporation with the Secretary of State, State of Florida.
