each a natural person competent to contract, hereby associate themselves together to form a corporation for profit under the Laws of
the State of Florida.

ARTICLE I

The name of this corporation shall be T & S Quality Service, Inc.

ARTICLE II

The general nature of the business to be transacted and carried on shall be:

- A. To carry on and conduct any lawful business in the State of Florida, including but not limited to, the business of operating a landscaping business.
- B. The nature of business shall be deemed to include all the rights, powers and privileges now afforded by the laws of the State of Florida, and such rights as may hereafter be extended by the laws of Florida to corporations for profit.

ARTICLE III


