The name of this corporation is DOUBLETREE CABINETS, INC.

ARTICLE XII: AMENDMENT

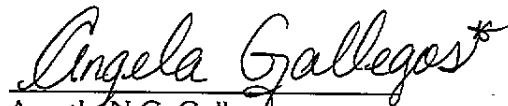

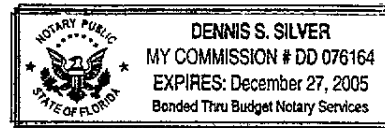

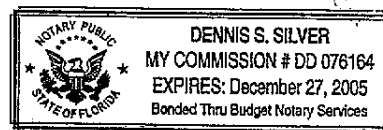
