**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
GURLEY CONSULTING GROUP, P.A.**

Pursuant to Section 607.1007, Florida Statutes, Gurley Consulting Group, P.A., a corporation organized under the laws of the State of Florida, and assigned document number P02000003455 (the "Corporation"), by its undersigned President, has adopted the following Amended and Restated Articles of Incorporation:

1. Name. The name of the Corporation is:

Gurley Consulting Group, Inc.

2. Principal Office and Mailing Address. The address of the principal office and the mailing address of the Corporation is:

3. Purpose. The Corporation is organized to transact any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act as it now exists or may hereafter be amended or supplemented.

4. Authorized Shares. The Corporation is authorized to issue 1,000 shares of common stock having a par value of \$1.00 per share. No share shall be issued except upon payment to the Corporation of the par value of the share in cash or other consideration permitted by law as payment for shares.

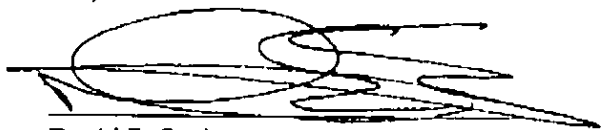

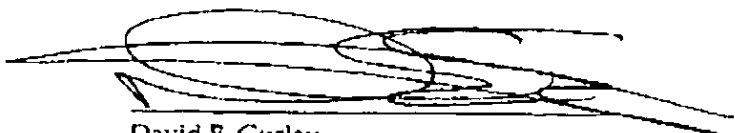
