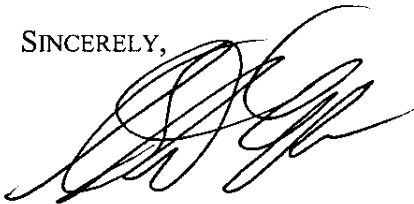
DEAR SIR/MADAM,
