Name. The name of this corporation is CLADDAGH Purchasing, Inc.

ARTICLE II

Duration. This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

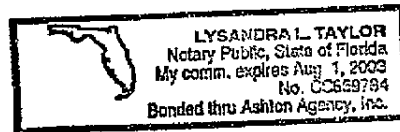

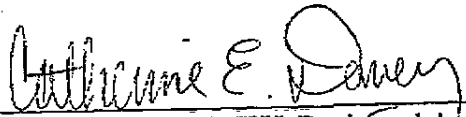
