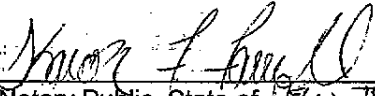

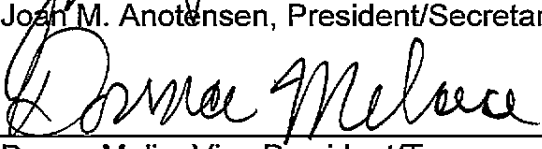
The undersigned, being all the shareholders and Directors of LABEL QUEST CORPORATION, hereby consent to the following amendment to the Articles of Incorporation:
