
ARTICLE IX.

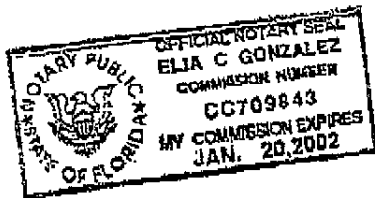
