## Articles of Incorporation of Cox Dental Lab, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME. The name of the corporation shall be Cox Dental Lab, Inc..

ARTICLE II. PURPOSE. The purpose of the corporation shall be for the preparation of bridges, crowns and any and all prosthetics for the mouth and any and all business permitted under the laws of the State of Florida. The corporation may own real property and undertake any other lawful activity in the furtherance of the purposes set forth.

ARTICLE III. PRINCIPAL OFFICE. The address of the principal place of business of this corporation shall be 12002 NW SR 45, High Springs, FL 32643, and the mailing address of the corporation shall be P.O. Box 22, High Springs, FL 32655.

ARTICLE IV. CAPITAL STOCK. The number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock, with a par value of \$1.

ARTICLE V. INITIAL REGISTERED AGENT AND ADDRESS. The initial registered agent of the corporation is Charles G. Cox, Jr., and the initial registered office of the corporation is 12002 NW SR 45, High Springs, FL 32643.

ARTICLE VI. INCORPORATOR. The incorporator of the corporation is Charles G. Cox, Jr., whose address is P.O. Box 22, High Springs, FL 32655.

ARTICLE VII. DIRECTOR. The initial director of the corporation is Charles G. Cox, Jr., whose address is P.O. Box 22, High Springs, FL 32655. The number of directors may be raised or lowered by amendment of the bylaws of the corporation but in no case shall be less than one.
