**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
THE KESLER TEAM, P.A.**

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, **THE KESLER TEAM, P.A.**, adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is **THE KESLER TEAM, P.A.**
2. The original Articles of Incorporation for the corporation were filed on January 11, 2002, and assigned Charter No. P02000004072.
3. By written consent action executed on March 31st, 2003 by the shareholders and sole director of the corporation, the shareholders and sole director have approved, authorized and directed that the Articles of Incorporation shall be amended to change the name of the corporation to "**CRAIG A. KESLER, P.A.**". The amendment was approved by the shareholders of the corporation and the number of votes cast for approval was sufficient.
4. Article I of the Articles of Incorporation is hereby amended to read as follows:
