Article I- NAME

The name of this corporation is Jennifer Labbe, P.A.

Article II- Principal Office

The mailing office of this corporation shall be:

Article III- PURPOSE

The corporation is organized for the purpose of rendering specific professional service as attorneys.

Article IV- CAPITAL STOCK

The Corporation is authorized to issue 1,000 shares of \$1.00 par value common stock which shall be designated as "Common Shares."

Article IX- INDEMNIFICATION

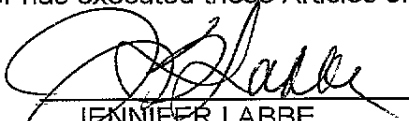
The corporation shall indemnify any Office or Director, or any former Officer or Director, to the full extent permitted by law.

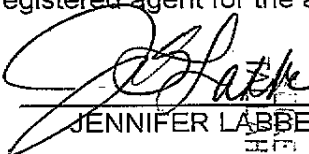
