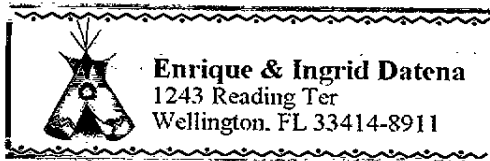

Articles of Incorporation. of Jose Enrique Datena, Inc.

I, the undersigned, being a natural person, does hereby act as incorporator in adopting the fallowing articles of corporation for the purpose of organizing a stock corporation pursuant to the provisions of the State of Florida, including particularly, Chapter 607, Florida Statutes, and for that purpose, I do hereby certify, declare and set as follows, to wit:

Article I- Name.

FIRST: The name of the corporation (hereinafter called the corporation) is **Jose Enrique Datena, Inc.**
The Address of the principal office of this corporation shall be 1243 Reading Terrace, Wellington, Florida 33414, and the mailing address should be the same.

Article II- Term of Existence.

SECOND: The duration of the corporation shall be perpetual.

Article III- Nature of Business.

THIRD: The purpose of the corporation is organized, which shall include the transaction of any or all lawful business for which corporations may be incorporated under the provisions of the State of Florida Stock Corporation Act, are as follows:
To provide painting and painting and painting related services and to market and sell any service related to painting. To have, in furtherance of the corporate purposes, all of the powers conferred

FOURTH: The maximum number of Shares of Stock, h
that this corporation has authority to have outstanding at any one
time is 7,500 shares of common stock having \$1 par value per
share.

Article V- Address.

FIFTH: The street address of the initial registered office

Article VI- Special Provision.

SIXTH: The Corporation shall be organized to comply
with the provisions of the subchapter S of the Internal Revenue

therein.


