

## Articles of Incorporation. of Jose Enrique Datena, Inc.

I, the undersigned, being a natural person, does hereby act as incorporator in adopting the fallowing articles of corporation for the purpose of organizing a stock corporation pursuant to the provisions of the State of Florida, including particularly, Chapter 607, Florida Statues, and for that purpose, I do herby certify, declare and set as follows, to wit:

#### Article I- Name.

FIRST: The name of the corporation (hereinafter called the corporation) is **Jose Enrique Datena**, **Inc**. The Address of the principal office of this corporation shall be 1243 Reading Terrace, Wellington, Florida 33414, and the mailing address should be the same.

#### Article II- Term of Existence.

SECOND: The duration of the corporation shall be perpetual.

#### Article III- Nature of Business.

THIRD: The purpose of the corporation is organized, witch shall include the transaction of any or all lawful business for witch corporations may be incorporated under the provisions of the State of Florida Stock Corporation Act, are as follows:

To provide painting and painting and painting related services and to market and sell any service related to painting. To have, in furtherance of the corporate purposes, all of the powers conferred

upon business corporations organized under the State of Florida, Stock Corporation Act.

#### Article IV- Capital Stock.
