## ARTICLES OF INCORPORATION OF MARINE MEDIC, INC.

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit, Chapter 607 of the Florida Statutes.

#### **ARTICLE 1 - NAME**

The name of the Corporation is **MARINE MEDIC**, **INC**., hereinafter referred to as the "Corporation."

#### **ARTICLE 2 - PURPOSE OF CORPORATION**


