

ARTICLES OF INCORPORATION OF C. S. LINDOW, INC.



ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is C. S. LINDOW, INC., and the principal address and principal place of business is 4036 8TH STREET SOUTH, ST. PETERSBURG, FLORIDA 33705.

ARTICLE II - REGISTERED OFFICE AND AGENT
