- SECRETARY OF STATE The name of the corporation is BEAUTIFUL TRANSITIONS, INCALLAHASSEE FLORIDA 1.
- 2. The principal place of business and mailing address of the corporation is 940 Clearwater-Largo Road, Unit 103, Clearwater, Florida 33770.
- 3. The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Florida.
