

Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, filed January 14, 2002, #P02000004388,

FIRST: The Capitol Stock is amended:

From: The aggregate number of shares which the corporation is authorized to issue is One Thousand Shares (1,000). The shares shall be of a single class and shall have a par value of One Dollar (\$1.00) per share.

To: The aggregate number of shares which the corporation is authorized to issue is One Hundred Thousand Shares (100,000). The shares shall be of a single class and shall have a par value of Ten Cents (\$0.10) per share.

SECOND: The amendment was adopted by the Board of Directors on the 30th day of January, 2002.

THIRD: No stock has yet been issued in the corporation.
