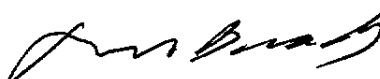

ARTICLE ONE - NAME

The name of the corporation is Cox Ventures VII, Inc.

The corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.

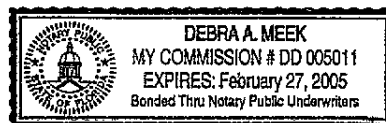
