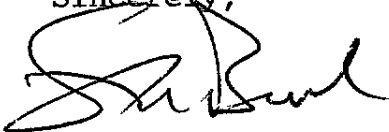

I, the undersigned natural person of the age of twenty-one years or more, acting as incorporator under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of this corporation is STEVEN R. BURK, P.A.

ARTICLE II. GOVERNING LAW

This corporation is organized pursuant to the provisions of the Florida General Corporation Act.

ARTICLE III. DURATION

The period of its duration is perpetual, commencing on the date of execution of these articles on January 7, 2002.

ARTICLE IV. PURPOSE

This corporation is authorized for the purpose of operating a law practice employing one or more attorney(s) and support personnel, and for transacting any lawful related business activities.

ARTICLE V. CAPITAL STOCK

This Corporation is authorized to issue One Hundred (100) shares of One Cent (\$.01) per value stock.

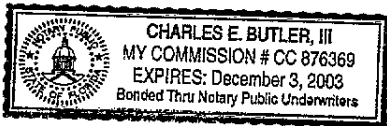
