# ARTICLES OF INCORPORATION

OF

# FOCUS SOUTH, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

### ARTICLE

The name of the corporation is Focus South, Inc.

## ARTICLE II

The duration of the corporation is perpetual.

# ARTICLE III

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

## ARTICLE IV

The amount of capital stock of this corporation shall be ONE HUNDRED SHARES (100) at Ten Dollars (\$10.00) par value stock, which stock shall be non-assessable to be held, sold and paid for at such time and in such manner as the Board of Directors may, from time to time, determine. All of the capital stock shall be common stock.

### ARTICLE V

The corporation shall commence business on filing with the Secretary of State.

## ARTICLE VI

The principal place for the transaction of its business shall be 20248 Country Club Drive, Estero, Florida 33928-2002. That said corporation shall have the authority to do business at such other place or places within or without the State of Florida, as the corporation may be resolution designate.

# ARTICLE VII

The corporation shall have a Board of one (1) Director, and the Board may be increased to not more than five (5) Directors. The number of Directors each year may be determined by the shareholders at their annual meeting, or may be fixed by the By-Laws.

# ARTICLE VIII

The officers by whom the business of said corporation shall be conducted shall be a President, who shall be a Director, a Vice-President, a Secretary and a Treasurer and such other officers, agents and Directors, who shall be chosen in such manner, hold their office for such term and have such powers and duties as may be prescribed by the By-Laws as determined by the Board of Directors.
