# ARTICLES OF INCORPORATION

OF

# Stone Creations of Brevard, Inc.

## ARTICLE I - NAME

The name of the corporation is Stone Creations of Brevard, Inc., 112 Kristi Drive, Indian Harbor Beach, Florida 32937 (Principal Office of Registered Agent).

## ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

## ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.

# ARTICLE IV - CAPITAL STOCK
