**ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida business corporation act hereby adopt the following articles of incorporation:

**ARTICLE I  
NAME**

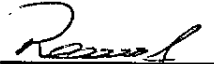

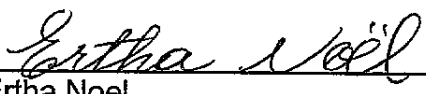

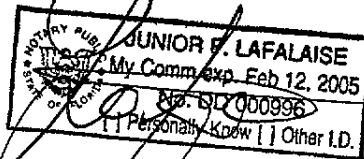
