

ARTICLES OF INCORPORATION

of

COMMERCIAL BROKERS INTERNATIONAL, INC.

(A For Profit Corporation)

ARTICLE I - NAME

The name of this Corporation is:

ARTICLE II - PRINCIPAL OFFICE
