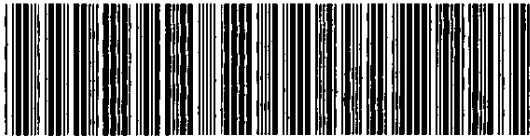

2. The change of the corporation's name was authorized on February 18, 2010, and approved by a unanimous consent of all of the sole shareholder and sole director of the corporation.

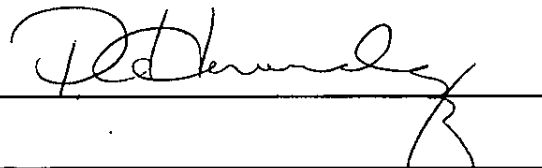
