ARTICLES OF INCORPORATION

OF

COMMUNICATIONS WORLD SERVICES, INC.



<u>ARTICLE I - NAME</u>

The name of the corporation is **COMMUNICATIONS WORLD SERVICES**, INC. (hereinafter called the "Corporation").

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the Florida Business Corporation Act of the State of Florida.

ARTICLE III - CAPITAL STOCK

The authorized capital stock of this Corporation shall consist of 100 shares of Common Stock, \$1.00 par value. Except as otherwise provided by the Florida Business Corporation Act, each outstanding share of Class A Common Stock is entitled to one vote on each matter submitted to a vote at a meeting of the shareholders.

ARTICLE IV - INITIAL REGISTERED AGENT

ARTICLE V - INITIAL PRINCIPAL OFFICE

ARTICLE VI - INITIAL BOARD OF DIRECTORS

The Corporation shall have one (1) director initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the Corporation, but shall never be less than one.
