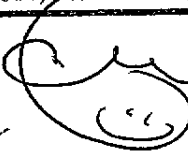

II.

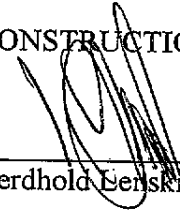
The date of the amendment's adoption is 2/11, 2002.
