ARTICLE II - ADDRESS

This Corporation shall have perpetual existence.

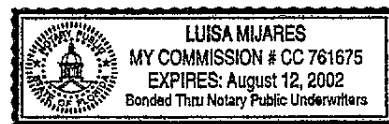

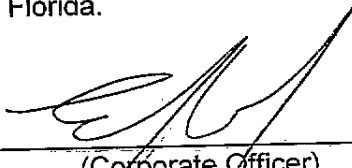

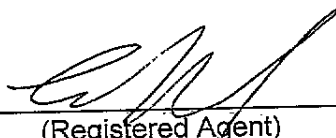
