ARTICLE I - NAME

The name of this corporation is Advanced RF Communications, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - COMMENCEMENT OF CORPORATE BUSINESS

This corporation requests the date of corporate existence of January 1<sup>st</sup>, 2002.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT
