
ARTICLE VI - Initial Registered Agent

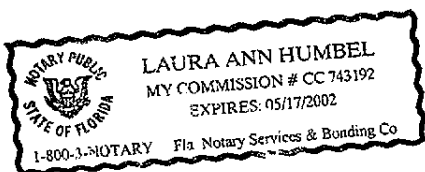
