CERTIFICATE OF INCORPORATION  
OF

1. Name.

The name of the Corporation is ~~JCAA ENTERPRISES, INC.~~ JCAA ENTERPRISES OF LAKE MARY  
INC

2. Principal Office and Registered Agent.

Its registered office in the State of Florida is 720 Silverwood Drive, in the City of Lake Mary,  
County of Seminole. The name of its registered agent at such address is Jeffrey A. Velez.

3. Purposes.

The nature of the business or purposes to be conducted or promoted is to engage in any lawful  
act or activity for which corporations may be organized under the General Corporation Law of  
Florida.

4. Capital Stock.

The total number of shares of capital stock that the Corporation shall have authority to issue is  
1,000, all of which are to be common stock with "par value of one dollar (\$1.00) per share".

5. Incorporator.

7. Liability of Stockholders.

The private property of the stockholders shall not be subject to the payment of corporate debts.

8. Management.

Subject to the provisions of the laws of the State of Florida, the following provisions are adopted  
for the management of the business and for the conduct of the affairs of the Corporation, and for  
defining, limiting and regulating the powers of the Corporation, the directors and the  
stockholders:

- (a) The books of the Corporation may be kept outside of the State of Florida at such place or  
places as may from time to time be designated by the Board of Directors.
- (b) The business of the Corporation shall be managed by its Board of Directors; and the  
Board of Directors shall have power to exercise all the powers of the Corporation, including  
(but without limiting the generality hereof) the power to create mortgages upon the whole or  
any part of the property of the Corporation, real or personal, without any action of or by the  
stockholders, except as otherwise provided by statute or by the Bylaws.
- (c) An increase in the number of directors shall be deemed to create a vacancy or vacancies  
in the Board of Directors, to be filled in the manner provided in the Bylaws. Any director or  
any officer elected or appointed by the stockholders or by the Board of Directors may be  
removed at any time, in such manner as shall be provided in the Bylaws.

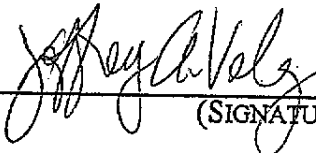
