ARTICLE XIII

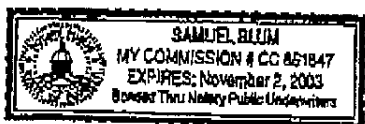


