The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

**Article 1: Name.** The name of the Corporation is: JACOBS & BARNES CONCRETE, INC.

**Article 2: Duration.** The duration of the Corporation is perpetual.

**Article 3: Purpose.** The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

**Article 4: Capital Stock.** The aggregate number of shares which the Corporation is authorized to issue is 100 (One Hundred) shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 (One Dollar) per share. The initial Shareholders are: JOSHUA C. JACOBS, 3228 TANGLEWOOD DRIVE, SARASOTA, FL 34239 and WALTER BARNES, 5323 WOODVALE DRIVE, SARASOTA, FL 34232 and each shall retain 50% ownership of the stock.

**Article 5: Principal Office, Initial Registered Office and Agent.** The street address of the principal office of the Corporation is: 3228 TANGLEWOOD DRIVE, SARASOTA, FL 34239. The name of the initial Registered Agent and address is: WALTER BARNES, 5323 WOODVALE DRIVE, SARASOTA, FL 34232.

**Article 6: Initial Board of Directors.** The number of Directors constituting the initial Board of Directors is two. The number of Directors may be increased from time to time in accordance with the bylaws but shall never be less than 1 (One). 

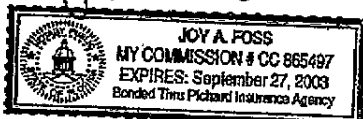
