The number of shares that the corporation is authorized to issue is 1000 all of which are of a par value of \$1.00 each and are of the same class and are Common shares.

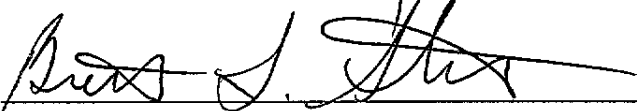
