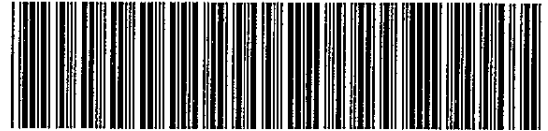

R & A ENTERPRISES OF CENTRAL FLORIDA, INC.

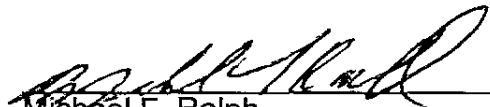
THIRD: The amendment was approved by the shareholders. The vote was unanimous; hence, the number of votes cast for the amendment was sufficient for approval.
