

ARTICLES OF INCORPORATION
of
Quehuong Pham, M.D., P.A.

The undersigned natural person, who is licensed or otherwise legally authorized to practice the profession of medicine in the State of Florida, hereby associates herself in accordance with the Florida Professional Services Act, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I: NAME

The name of the corporation is Quehuong Pham, M.D., P.A.

ARTICLE II: DURATION

This Corporation shall exist perpetually.

ARTICLE III: PURPOSE

This corporation is organized to engage in the practice of medicine as a professional corporation, and to own real and personal property, enter into contracts and engage in any lawful business activity necessary for the rendering of such professional services.


ARTICLE VIII: AMENDMENT


ARTICLE IX: REGISTERED AGENT
