ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF SOUTH FLORIDA 1&G INC.



Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its Articles of Incorporation, originally filed on January 18, 2002.

Article IV, is hereby amended as follows:
