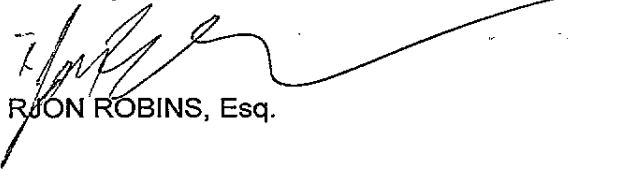

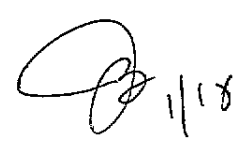

Articles of Incorporation
Of
TURNDAY Corporation

Article 1

Corporate Name

The name of this corporation shall be "TURNDAY Corporation"

Article 2

Principal Office and Mailing Address

EFFECTIVE DATE
01-14-02

The principal office and mailing address of the Corporation is 2432 Ramblewood Court, Tallahassee, FL. 32303.

Article 3

Nature of Corporate Business

The general nature of the business to be transacted by this Corporation shall be to engage in business for profit and it is organized for the following general purposes:

- (a) To engage in any and all lawful business permitted under the laws of the United States and the State of Florida; and
- (b) To make loans to or hold stock in other business entities, and enter into partnerships, limited partnerships, and joint ventures with other business entities.

Article 4

Capital Stock

This Corporation shall have authority, acting by its Board of Directors, to issue not more than 100 shares of common class at \$1 PAR VALUE per share, that have unlimited voting rights of one vote per share for the election of directors and with respect to other matters submitted to a vote of shareholders, and that are entitled to receive the net assets of the Corporation upon dissolution after payment of the Corporation's debts.

Article 5

Term of Existence

This Corporation shall have perpetual existence.

Article 6

Effective Date of Corporation

The Corporation shall commence business on January 14, 2002.

Article 7

Registered Agent

Board of Directors

The initial Board of Directors shall consist of (2) members, the names and addresses of whom are as follows:

The person(s) named as the initial Directors shall hold office for the first year of existence of this Corporation, or until their successors are duly elected or appointed and qualified, whichever occurs first.

Article 9

Indemnification

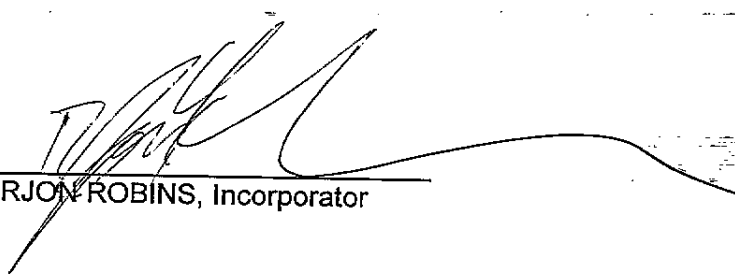
No Director or Officer of the Corporation shall be personally liable to the Corporation or its shareholders for monetary damages for breach of his/her duty of care or other duty as a Director; provided that this provision shall eliminate or limit the liability of a Director or Officer only to the extent permitted from time to time by the Florida Business Corporation Act or any successor law or laws.
