# Articles of Incorporation Of TURNDAV CARONTICAL

#### Article 1

# **Corporate Name**

The name of this corporation shall be "TURNDAV Corporation"

# Article 2

# **Principal Office and Mailing Address**

01-14-02

# Article 3

# **Nature of Corporate Business**

The general nature of the business to be transacted by this Corporation shall be to engage in business for profit and it is organized for the following general purposes:
