ARTICLES I - NAME

This name of this organization is Marric Properties, Inc.

ARTICLE II - PURPOSE

This company is organized for the purpose of engaging in the business of purchasing, leasing and otherwise making real property investments, for the accomplishment of said purposes, and to do all and other things incidental to them, or connected with them, that are not forbidden by Florida corporation laws or by other laws, or by these Articles of Incorporation, and to carry out said purpose in any state, territory, district, or possession of the United States or in any foreign country, to the extent that these purposes are not forbidden by the laws of that state, territory, district, or possession of the United States, or by the foreign country.

All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.


ARTICLE VII - INDEMNIFICATION

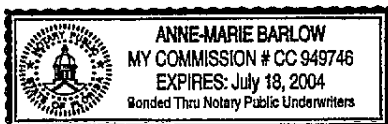




